It wad be oor darg as Claught Seekitars, thegither wi oor billies in tha Claught Seekitar Agentrie, furtæ fen tha wark o tha Männystërs in tha Cooncil an furtæ gie a cast tae makkin siccarr o tha gleg an eydent fordèrin o its hanmlin.

In tha saiconn fu towmond tha Cooncil haes haed tha owerance o tha stellin o tha Noarth/Sooth Curns, furbye tha fendin o ayebidin aisements an tha doon-settin o Heid Guiders an ither foremaist dargers. Throch twa thoosan an yin tha Curns syne

wus mair an mair in a guid wye o yokkin til thair fu ontaks o darg. Thenoo thar's a din o guid forderin in aa tha airts at's täen in wi quhit tha Cooncil's gart dae.

We'r fur pittin doon oan tha scrow tha wye we'r muckle ableeged tae aa tha Männystërs fræ tha baith owerances an tae thair wicemen fur thair stieve pall o tha Seekitar Agentrie an tha siccarr honestie o thair trockan wi oorsels as Claught Seekitars an oor dargers.

We'r lippenin oan tha Cooncil tae haud tae winnin ower an tae makkin a richt differ in maittërs at baith pairts o tha islann wullen tha guid o in troth.


CHAIPTÈR 1

WITTINS ANENT THA NOARTH/SOOTH COONCIL O MÄNNYSTÈRS

THA NOARTH/SOOTH COONCIL O MÄNNYSTÈRS

- 1.1** Tha Noarth/Sooth Cooncil o Männystërs wus stellit oan Thursday 2 Decemmer 19 an 99 quhaniver tha British-Airish Greeance wus poustie gat. Tha British an Airish Govermenns pit thair hann tae thon as pairt o tha Greeance at wus wun tae oot o tha Monie-Pairtie throchin ben Bilfawst oan Guid Friday, 10 Aprile, 19 an 98 ("tha Greeance"). Tha Greeance gars tha Noarth/Sooth Cooncil o Männystërs bräng thegither tha boadies at haes guidin ontaks in Norlin Airlann an tha Airish Governmenn tae graith apen discourse, complutherin an jeein ben tha islann o Airlann - takkin in bi wye o throchin oan tha steid o tha hale islann an athort tha meerin - anent maittërs tha baith o thaim leuks tha gate o an at ilka Owerance, Noarth an Sooth, haes tha wisin o. Tha NSCM taks in Männystërs o tha Norlin Airlann Owerance an tha Airish Governmenn, neeborin tae forder complutherin aqueesht tha baith bâts o tha islann tha wye the'll baith can hae tha guid o't.
- 1.2** Tha Greeance desarnt at yins wud ootwale twal or mair shaidin airts at wud hæ complutherin tha wye tha baith wud hæ tha guid o't unnèr tha owerance o tha Cooncil. The wud throch complutherin in thae airts twa roads - effeirin till sâx or mair o thaim bi wye o curns at's tae tha fore aareadie in ilka sindërie owerance (spake o furbye as tha Airts o Complutherin), an effeirin till sâx or mair ither yins bi wye o brank-new Noarth/Sooth Throchin Curns (spake o furbye amang tha hale feck o fowk as tha Noarth/Sooth Curns) daein thair darg in a gate at's athort tha meerin or ower tha hale islann.
- 1.3** Tha Greeance desarnt furbye at tha twal Airts mintit wud be ootwalit an compluthert wi tha forespaikers o tha Norlin Airlann Athort-Gaein Owerance an tha Airish Governmenn, tha quhile haein apen discourse wi tha British Governmenn as pairt o tha darg ontak o tha athort-gaein Noarth/Sooth Cooncil o Männystërs.
- 1.4** Throchin aqueesht tha pairties an tha twa Govermenns haed its feck in complutherin anent thae twal airts. Tha owercum o tha throchin wus pit forrits in a Claugt Spaik ootpit wi tha Heid Männystèr (ootwalit) an Heid Männystèr Depute (ootwalit) oan 18 Decemmer 19 an 98.
- 1.5** The hæ condescendit oan Sâx Airts as tha yins quhaur complutherin wud be fordërt wi tha brank-new Noarth/Sooth Curns in thon spaik. The wur:

1.7	At tha biddin o tha Spaik o 18 Decemmer 19 an 98, tha British an Airish Governemens throchit a Greeance eftèr oan tha stellin o tha Noarth/Sooth Curns - "Greeance aqueesht tha Governemm o Airlann an tha Governemm o tha Claugt Kängrick an Norlin Airlann stellin Throchin Curns," at the pit thair hann tae tha 8 Mairch, 19 an 99 ("tha British-Airish Greeance o 8 Mairch, 19 an 99"). Tha British-Airish Greeance o 8 Mairch 19 an 99 pit forrits wicelike tha dargs an stellin o tha Noarth/Sooth Curns an tha disponin at hauds fur tha baith o thaim.
1.8	Tha British-Airish Greeance o 8 Mairch, 19 an 99 wus gien ootcum in tha laas ben ilka airt, Noarth an Sooth, throch tha Noarth/Sooth Complutherin (Throchin Curns) (Norlin Airlann) Biddin, 19 an 99, an tha British-Airish Greeance Aict, 19 an 99, as effeirin.
1.9	Tha wye it bes mintit abune, tha Greeance gart tha Noarth/Sooth Cooncil o Männystèrs compluther tha airts quhaur complutherin an throchin wad jee quhaniver it wus foregaithert in an athort-gaein gate. Sin thon's tha wye o't, tha Cooncil foregaithert in an athort-gaein gate oan 1 Decemmer, 19 an 99 in Bilfawst, at tha Tolsel Biggins, Stormount.
1.10	Ben this gaitherin, tha Cooncil homologatit wicelike tha twal airts an tha disponin effeirin til thaim pit forrits in shaidins 1.5 tae 1.8 abune.
1.11	Thae twal Airts bes tha owergate o thae maittèrs at tha Cooncil's fit tae desarn bi complutherin anent (a) roadins fur throchin sindèrie-wise in ilka owerance an anent (b) roadins an jeein oan tha steid o tha hale islann an athort tha meerin fur throchin wi tha Noarth/Sooth Curns. Aiblins the'll can hae mair graithin o thae disponins gin the hae complutherin in tha Cooncil, an gin the hae tha ae-yokit homologatin o tha Norlin Airlann Semmlie an tha Oireachtas, aye wi an ee tae tha bouns o tha docht an tha ontaks o tha twa Owerances.

- 2.1** Tha NSCM foregaithers in a wheen o layoots. It gaithers in Fu-Stellit Layoot wi tha Norlin Airlann Heich Cooncil forespaikers wisit wi tha Heid Männystèr an Heid Männystèr Depute an tha Airish Govermenn forespaikers wisit wi tha Taoiseach an tha Tánaiste. Tha darg o tha Fu-Stellit wud be tae hae a leuk ower tha complutherin ben tha islann an tha Noarth/Sooth heids o owerance. Tha NSCM gaithert in Fu-Stellit Layoot tha yince throch twa thoosan an yin. This wus in Blaklyn oan 30 Novemmer.
- 2.2** Tha NSCM foregaithers furbye in Heids o Owerance Layoot an tha Heich Cooncil o Ulstèr forespaikers is tha Heid Männystèr an Heid Männystèr Depute, an tha yin fur tha Airish Govermenn is tha Männystèr o Ootby Maîtters. Tha darg o tha Heids o Owerance Layoot bes furtae cast ower maîtters anent owerance an athort tha shaidins, takkin in effeirin til tha EU an tae redd onie tulyses. Tha forehann gaitherin o tha NSCM in Heids o Owerance Layoot wus hauden in Bilfawst oan 17 Decemmer twa thoosan an yin.
- 2.3** Tha NSCM foregaithers in Shaidin Layoot fur til owergang neeborin in tha compluthorert twal Airts or Shaidins, tha wye the'r descreevit in Chaïptèr 1. Tha NSCM gaithers effeirin til thir shaidins a wheen o tids ilka towmond. At thir gaitherins, tha forespaiker fur tha Airish Govermenn pairtie is tha Männystèr wi tha ontak fur thon Shaidin, an tha Norlin Airlann Owerance forespaikers is twa Männystërs ootwalit wi tha Heid Männystèr an Heid Männystèr Depute oan tha steid o chappin athort tha resydentërs, an yin o thaim fur ordnar tha Männystèr wi tha ontak o thon Shaidin ben tha Heich Cooncil. This gaes alang wi quhit tha Agreeance an tha Norlin Airlann Aict 19 an 98 condescends oan, at tha ingate o tha Heich Cooncil in tha NSCM maun be o a soart at wull mak siccar at thaim at gets yokkit in wull be frae athort aa resydentërs.
- 2.4** Throch twa thoosan an yin, a hale tot o 22 gaitherins in Shaidin Layoot wus hauden.
- 2.5** Aa tha desarns o tha NSCM bes compluthorert aqueesht tha twa pairties in tha Cooncil.

DARGS O THA COONCIL

- 2.6** Tha Cooncil throchs a wheen o dargs pack wi Shaidin Twa o tha Greeance. Thir wur pit forrits in tha Greeance thawye ablow:
- Tae niffer wittins, colloque an hae open discourse wi an ee tae complutherin anent maitters tha twa leuks tha gate o athin tha docht o baith Owerances, Noarth an Sooth;
 - Tae lay oot thair accoonts tae win tae greeance oan takkin up twynit roadins, in airts quhaur yins athort tha meerin an ower tha hale islann wull hae tha like quid o't, an at's athin tha docht o baith Owerances, Noarth an Sooth, makkin eydent fennin tae owercum onie tulyses.
 - Tae desarn wi compluthorin anent roadins fur throchin sindërie-wise in

- ilka owerance, in airts at's effeirin an haivefu unnèr tha docht o baith Owerances, Noarth an Sooth;
 - Tae desarn wi complutherin anent roadins an jeein oan tha steid o tha hale islann an athort tha meerin furtae be throchit wi tha Noarth/Sooth Curns.

Tha mair the hae a shire wisin o darg, the aa wark unnèr tha aa-lappin owerpang o tha Noarth/Sooth Cooncil o Männystërs an it maun be plain tae tha Cooncil, tha Oireachtas an tha Norlin Airlann Semmlie at the'r daein tha jonick wi fowk.
- 2.8** Tha Agentries/Curns is:
 Wattèrgates Airlann
 Tha Safétie o Mait Fordèrin Boord (SMFB)
 Tha Mercat an Hænnlin Graithin Curn (NifferinMercatAirlann)
 Tha By-Ordnar EU Dargs Curn (BEUDC)
 Tha Noarth/Sooth Boord o Leid (takkin in twa Agentries, thon's Foras na Gaeilge an Tha Boord o Ulstèr-Scotch)
 Tha Foyle, Carlingford an Airish Lichts Bailzies (FCALB) (takkin in twa Agentries, thon's tha Lochs Agentrie an tha Lichts Agentrie)
- 2.9** Effeirin til thrie o tha Curns, NifferinMercatAirlann, tha Noarth/Sooth Boord o Leid an tha FCALB, tha dargs o ilka Curn bes throchit wi tha NSCM. A fowerth Curn, tha SMFB, haes a Boord o wicemen at's walit wi tha NSCM furby. Effeirin til this yin, tha dargs o tha Curn bes throchit wi tha Heid Guider. Tha twa lave o tha Curns, Wattèrgates Airlann an tha BEUDC, daesnae hae Boards; adae wi ilk'ane o thir yins, tha dargs o tha Curn bes throchit wi tha Heid Guider.
- 2.10** Tha Noarth/Sooth Curns bes sillert frae hansells skaitl wi tha twa owerances, Noarth an Sooth. Tha Curns is lat tak oan dargers or micht tak oan ither owerlie boadies tae dae sindërie ae-yokit dargs. In tha foremaist sten o thair stellin, tha Curns fur tha maist feck o't haes gat tha lenn o owerlie leid dargers frae thair hame Departmenns, Noarth an Sooth. Still an withal, tha Curns haes taen oan dargers at's straucht ootwalit furbye.
- 2.11** Ye'll can hae mair wittins anent tha darg o tha Noarth/Sooth Curns frae tha Shaidin Fynnins in Chaptèr 5.
- ## AIRTS FUR COMPLUTHERIN
- 2.12** Tha Airts fur complutherin an tha shaidins at wus compluthert fur tha foremaist castin-ower wi tha NSCM bes tha yins follaein:
- Hurlin: roadin ettlín an graithin o complutherin athort tha meerin (tha mair complutherin in tha foremaist wye o't wud be effeirin til ettlins adae wi tha gates fur motòrs an railwyé caurs, it wud tak tent o maittërs at cums tae tha fore in tha shaidins anent herbours an dròmes), an safétie o tha gates fur motòrs an railwyé caurs;
 - Fairmin: colloque anent CAP maittërs, bastes an roadin anent tha heal o braird an screengin an kintra graithin;
 - Lear: lear fur weans wi by-ordnar wants (tha like o autism, deavin), scant o winnin in lear, dominies' lines, an nifferin o schuils, youngyins an dominies;

- Poustie: mishanter an misfaur ettilin; misfaur sairin, complutherin anent reikin o heich technologie, screengin intae chauncer an tha forderin o poust;
 - Yaird-hainin: screengin intae fennin o tha yaird, tha guidin o tha fushion o tha wattèr an tha guidin o redd in a gate athort tha meerin;
 - Reengin: the compluthert furtae stell a scrimpit-skaith hanlin in tha aucht o tha leid fur tha priggin o tha quid o tha islann o Airlann ootby as an airt fur reengin.
- 2.13** Mair wittins anent tha darg o tha Cooncil in thae airts is pit forrits in tha Shaidin Fynnins in Chaiptèr 5.

- 3.7** Tha Cooncil gat a fynnin anent tha oncum o darg daen wi tha Kemp-Curn stellit tae forder a learin anent tha stellin o a Scowth Noarth/Sooth Wisin Collogue. Tha Cooncil taen tent at mair wark maun be yokkit til, an compluthert at mair hanmlins anent tha maittèr wud gang forrits at tha furst Heids o Owerance gaitherin furbye anither fynnin anent oncum fur bein gien oot at tha nixt Fu-Stellit daeins.

- 3.9** Tha Cooncil compluthert furbye at tha Wisin Curn tae tha fore thenoo wud guide tha open discourse an pit forrits tae tha nixt NSCM Fu-Stellit daeins, a rede giein jimp wittins, wechtin an giein soumes fur tha moyens gaun bi tha owercum o tha open discourse an cumin tae threaps, takkin in oan throchin mintins, gin the wud be effeirin. - 3.10** Tha Cooncil gien a moyen o tha kists fur tha Noarth/Sooth Curns tae tha Airish Govermenn an tha Norlin Airlann Owerance fur twa thoosan an twa in tha soume o £54.37m/ 92.07m tha hale tot. Tha sindèrie inpits tae this soume wull be £40.01m/ 67.74m frae tha Airish Govermenn an £14.37m/ 24.33m frae tha Norlin Airlann Owerance. Tha Cooncil taen tent furbye o lippenin soumes adae wi Reengin Airlann Hannlin fur twa thoosan an twa o £26.78m/ 45.33m wi sindèrie inpits tae tha hale tot o £19.46m/ 32.95m frae tha Airish Govermenn an £7.31m/ 12.38m frae tha Norlin Airlann Owerance. - 3.12 Tha Cooncil taen tent o tha set thenoo adae wi tha Airish Govermenn's Darg fur Sonse an Jonick an its Leid Graithin Rede an tha Norlin Airlann Owerance's scrow Darg fur Govermenn.
- 3.13 Yins haed a colleague anent quhit-like tha ootcum fur tha sillerie-gates o tha baith owerances o tha dreidsum daeins o 11 Sectemmer twa thoosan an yin might be. Tha Cooncil compluthorert at ahinn tha hann the pit forrits a muckle-heftit pall fur tha sillerie-gates o tha baith owerances. Tha Cooncil castit ower quhitwyre tha reengin agentries oan tha islann o Airlann is graithin mintins tae mak an inlaik in tha dint oan reengin.
- 3.14 Thar wus a colleague furbye anent ettilin fur misfaurs wi an ee tae tha daeins o 11 Sectemmer twa thoosan an yin. The compluthorert at thar wus a uise fur haudin athort-meerin compluthorin in tha airt o poust an fur haein tha intimmers stellit in ilka owerance effeirin til ettilin fur skaithlie pratticks.
